



**Close all park restrooms (use portable toilets instead)**

**Dollar Amount:** \$771,910

**Positions Impacted:** 10 FTE

**Package Description:**

All the built restrooms in parks would be closed beginning July 1, 2012. This package would eliminate the opening/closing, operation, ongoing maintenance, and servicing of a majority of built restrooms sited within developed parks. A total of 189 toilet units would remain closed. Of these, 36 are open year-round and serviced (cleaned) daily. The rest are generally opened and maintained April 1-October 31, a total of 214 days. In lieu of those restrooms, one portable toilet unit will be installed per each two built restroom stalls (1:2 ratio). These portable restrooms would be sited annually and seasonally, based on current service levels. At least one ADA portable restroom unit will be placed at each site. All units will be serviced three times per week.

Not detailed are probable savings through utility costs – water and electrical savings, annual maintenance, and fleet services.

Restrooms NOT included in this package are at Hoyt Arboretum and Lower Macleay Park, as well as all built restrooms that are CLOSED or NOT directly maintained by PP&R staff as of FY 2011-12, including restrooms maintained through the Downtown Cleaning Service Contract; Pioneer Courthouse Square.

**What will happen as a result of the decision package/impact to the community:**

Restrooms open year-round and those open during the high use season, April-October, will remain closed and replaced with portable restroom units, at a 1:2 ratio. As park staff will not be cleaning/servicing these units daily, there is a higher probability of quality and cleanliness reduction in restroom options afforded to the public. Regular service to these units, three times weekly, would not equate to current cleaning standards provided at parks restrooms by daily and often more than daily service. Further, the 50% reduction of available restroom units will also reduce access to restroom facilities for patrons, particularly at high-use parks. Potential vandalism, including arson, to these units may also impact availability and use of these portable restroom units. Staff resources to respond to unscheduled maintenance needs will be significantly reduced.

Clearly, another impact is the esthetics of the park – many park restrooms are historical assets and porta-potties do not evoke the same ambiance.

**What alternatives exist for providing this service:**

Replacing restrooms with portable toilets at a 1:2 ratio

**How the results of the package will be measured:**

The results of this package will be measured by the community response to this cut, as well as the comprehensive cost savings realized on service and replacement costs for the portable restroom units.
